Georgia Nuisance Law Provides Relief for Wronged Landowners

Under Georgia law, unlike the law in many other states, a plaintiff cannot use the provisions of an employment handbook or other personnel policy to show that he or she: is guaranteed employment for a particular length of time; cannot be discharged or disciplined "at will"; or was wrongfully discharged.

Labor and Employment Laws in the State of Georgia

The Georgia Code reads that "necessary expenses consequent upon an injury are a legitimate item in the estimate of damages." Ga. Code Ann., § 51-12-7. To warrant future medical expenses, there must be evidence that the injury will require that future medical attention. *Massie v. Ross*, 211 Ga.App. 354, 354, 439 S.E.2d 3, 3 (1993).
